Something to work on, the board never sends out a newsletter or an update to let the community know what's actually going on. For example, we were notified in the winter that there were two vacancies on the board that an election would be held for in the spring. However, we were never updated on that process. 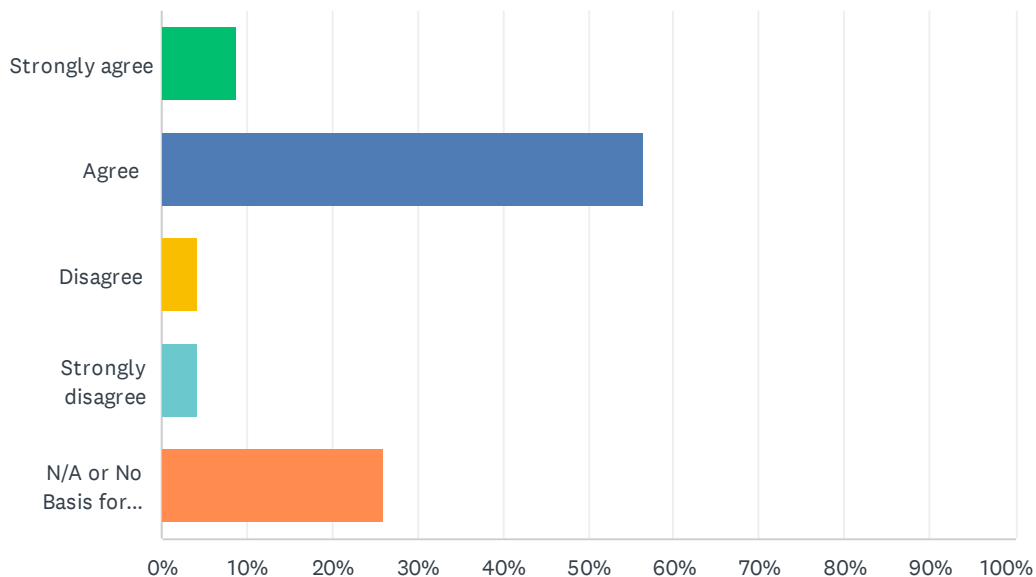

We all got ballots here in Gateway, and there was nothing in the ballot about the seats on the board. So the candidate told me they were put on the board by acclimation. This also happened last spring when there was a vacancy. I understand why you as a board decide to not hold an election, but it seems unkind to not notify your constituents about why you aren't holding an election and who is going to serve not he board now. It may help your reputation with the community if you were more "transparent" in this way. The meetings are being announced, but there is never any brief updates about what the board is working on. Maybe you could just post updates on the school website or something, instead of sending out community emails? Not sure what is the easier platform.
